### INTRODUCTION

This report provides summary information regarding University enrollments. The tables and graphs show enrollments for the past 11 years, i.e., 1996-2006.

## **HIGHLIGHTS**

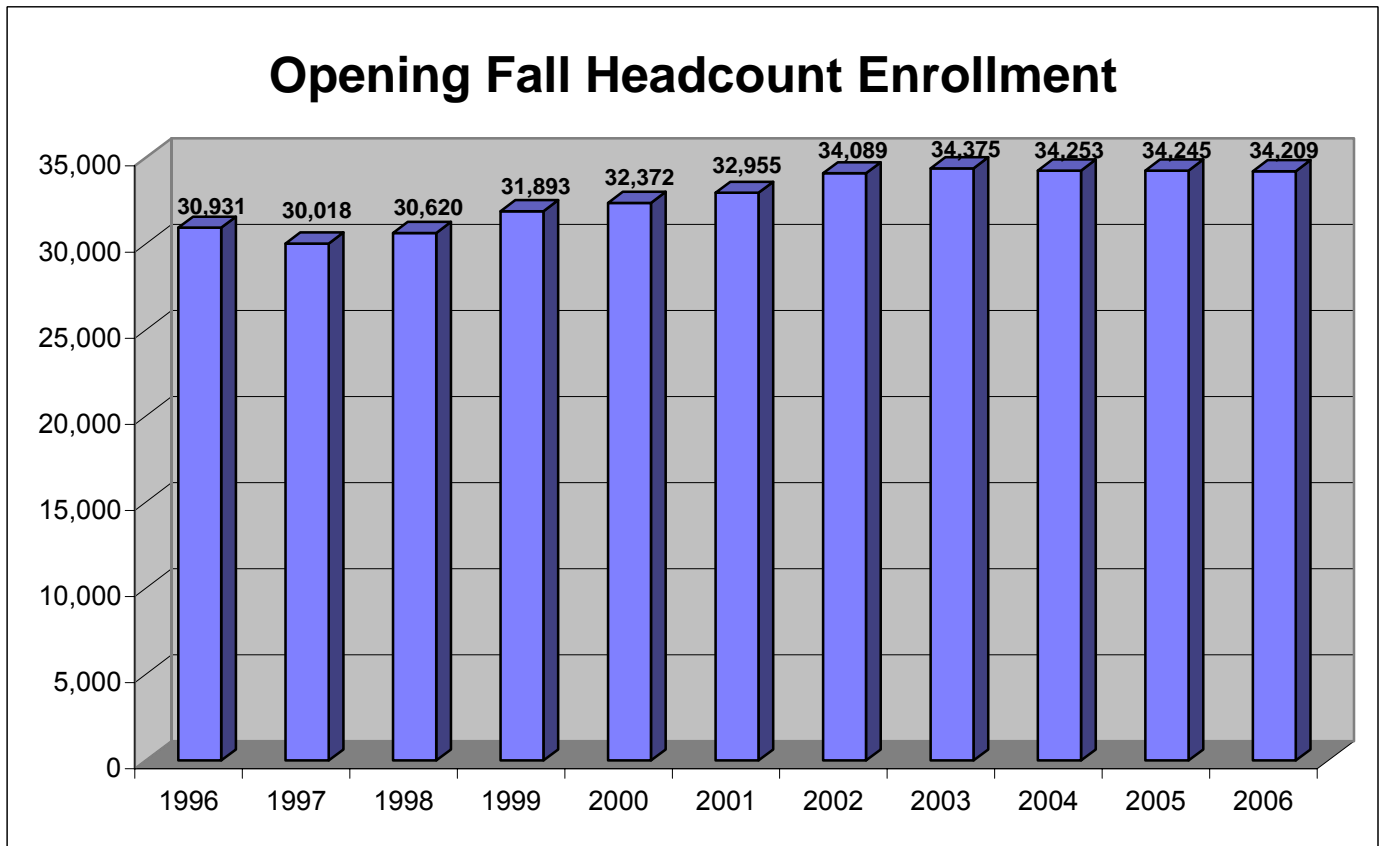
- **For the fifth year in a row, enrollment within the University of Maine System exceeds 34,000 students.**
- **At 34,209 students, UMS enrolls 74% of students currently enrolled in public postsecondary education and 55% of students in public and private postsecondary education combined.**
- **Compared to last fall, the number of full-time students is up by 61 and the number of part-time students is down by 97, a net decrease in headcount enrollment of 36 students. There are 20 fewer FTE students (-0.1%) compared to last fall's record high number.**
- **Students who are Maine residents number 29,862 which is 87.3% of total enrollment. In-state enrollment decreased by 121 students and out-of-state enrollment increased by 85 students to 4,347 students, an all-time high. International students (1,180) increased by 8 students and represent 3.4% of the student body.**
- **Of the 34,209 students, there are 21,212 women (62.0% of the student body) and 12,997 men (38.0%).**
- **Every county in Maine sends at least 300 students to the University of Maine System. The largest numbers come from Cumberland (6,020), Penobscot (4,922), and Kennebec (3,166).**
- **Students come from all but two states in the country, Louisiana and Oklahoma, plus the District of Columbia. A total of 55.2% of out-of-state students (excluding international students) come from the other New England states. Massachusetts alone accounts for 23.1% of students coming from other states.**
- **The University of Maine System has students from 83 different countries enrolled. The largest delegation comes from Canada (813 or 68.9%).**

### **HIGHLIGHTS CONTINUED**

- **There are a total of 3,361 students enrolled in distance learning courses in Fall 2006, down 1.4% from 3,407 students in Fall 2005. Distance learning credits are 13,788 compared to 14,434 in Fall 2005 (a decrease of 4.5 %). 2,545 students (75.7%) are enrolled only in distance learning courses.**

**A summary profile of distance learning students is as follows:**

- **87% are part-time**
- **72% are associate or non-degree**
- **79% are women**
- **80% are 23 years of age or older (51% are 31 years of age or older)**



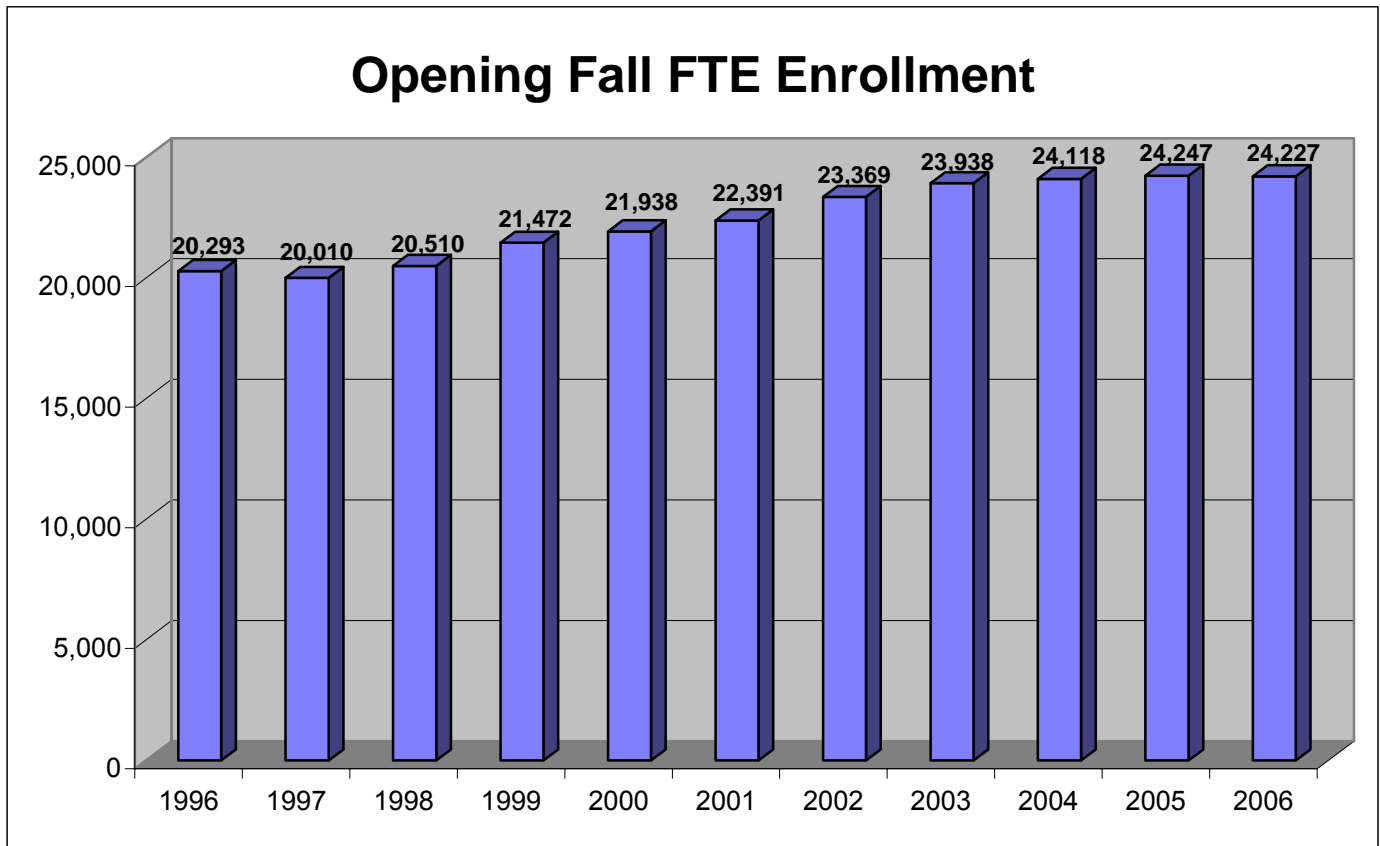

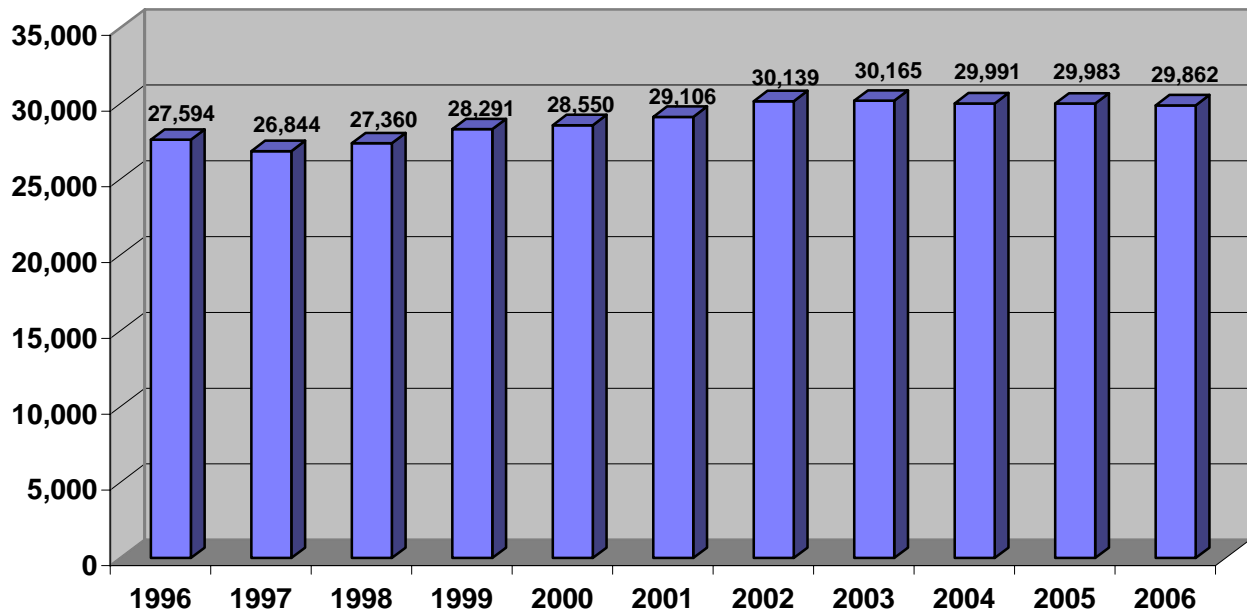

## OPENING FALL HEADCOUNT ENROLLMENT BY RESIDENCE, BY UNIVERSITY (1996-2006)

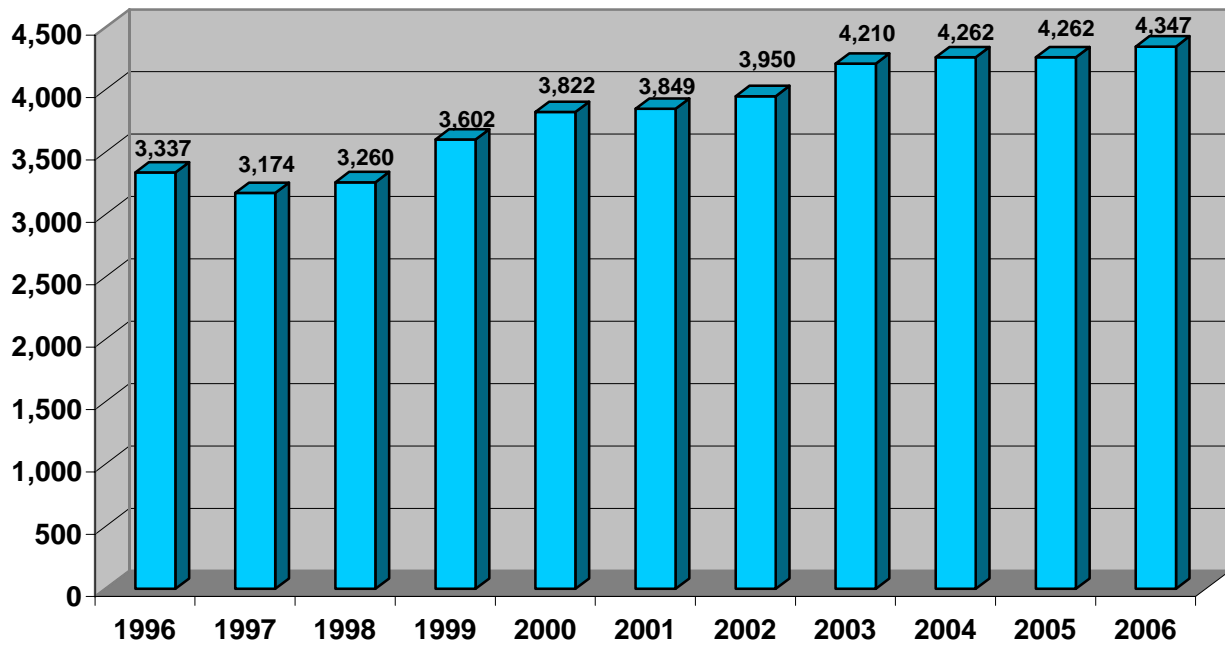

Opening Fall Out-of-State Enrollment

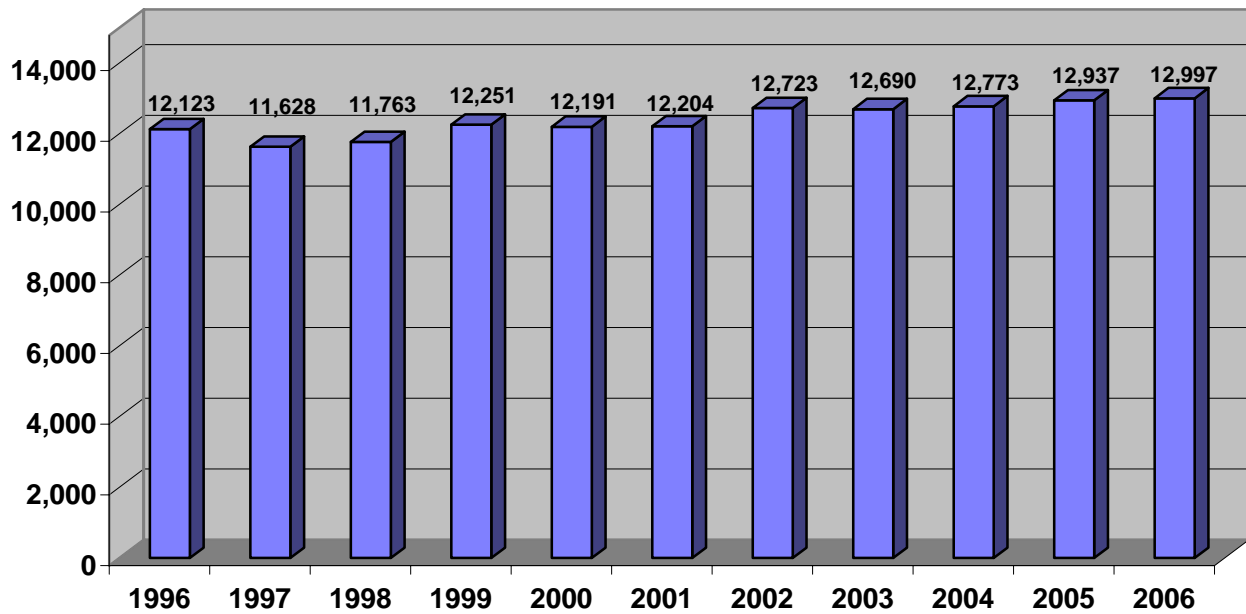

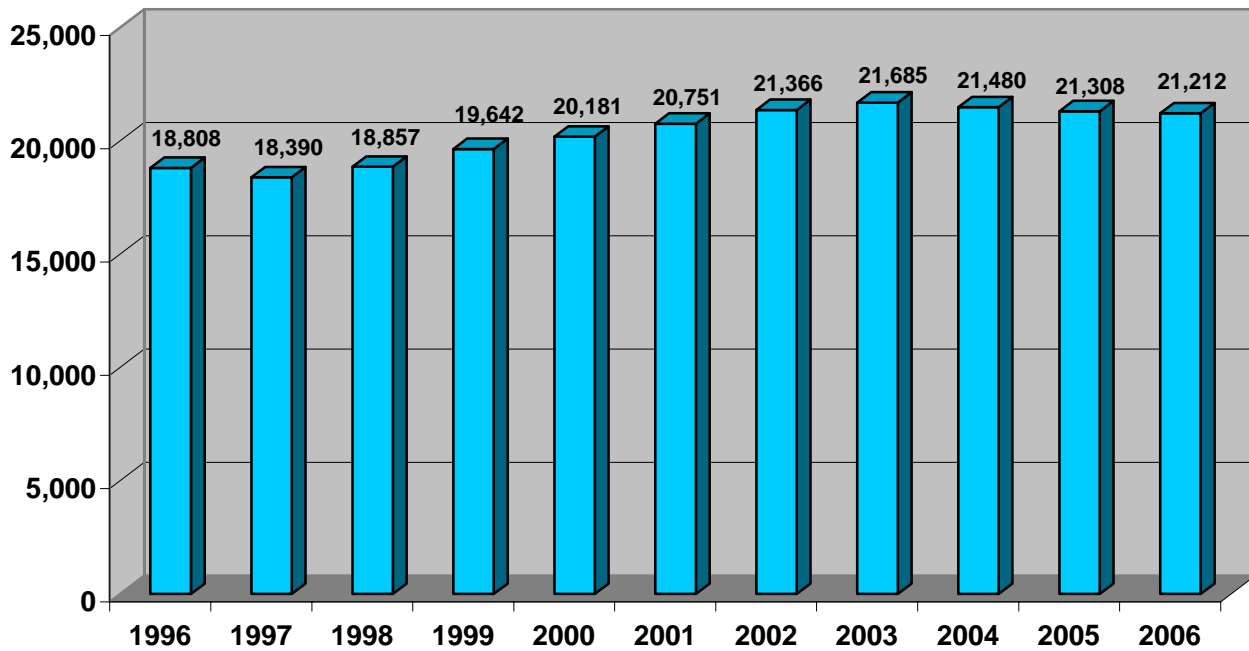

Opening Fall Enrollment - Women

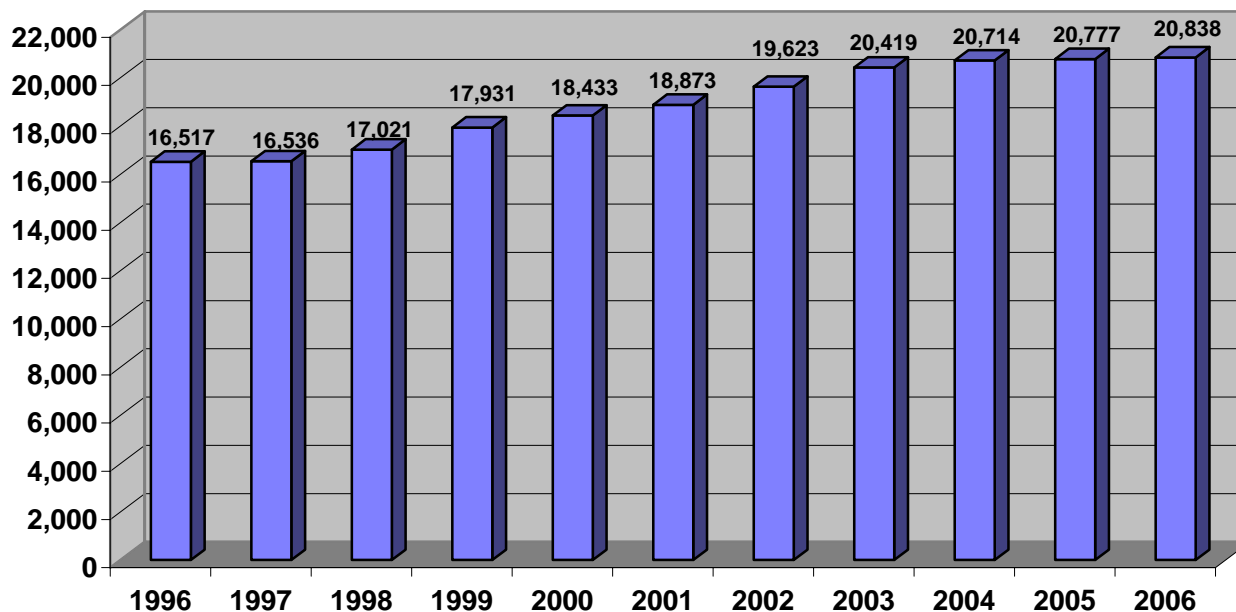

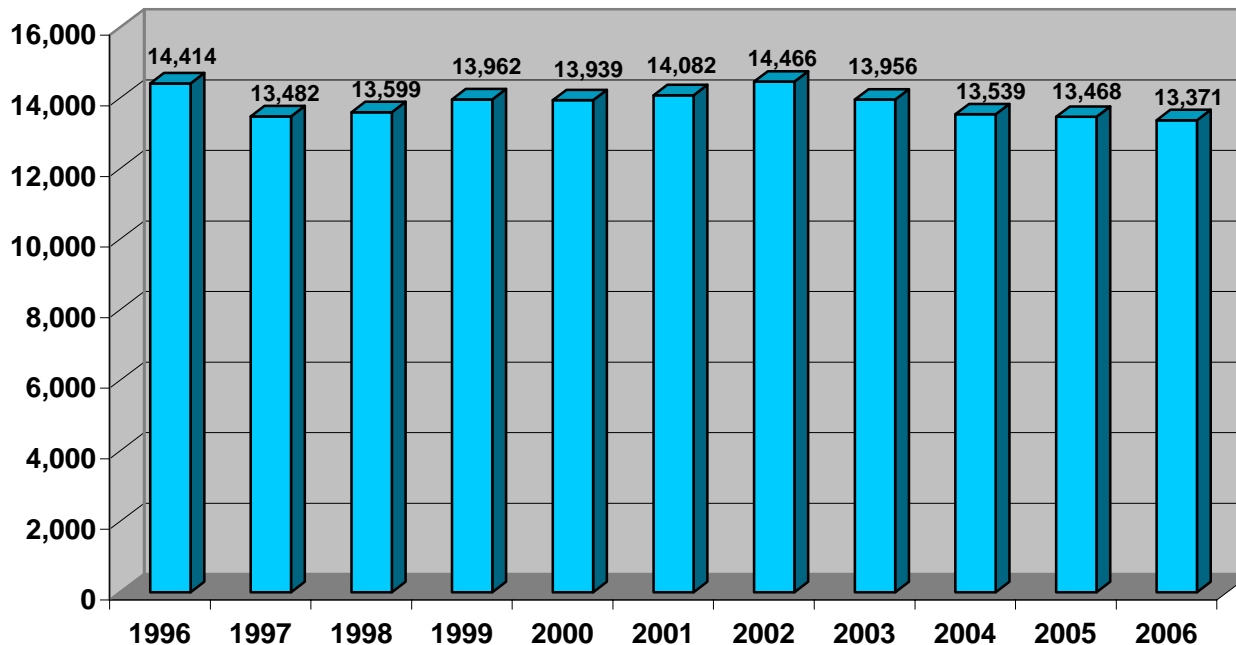

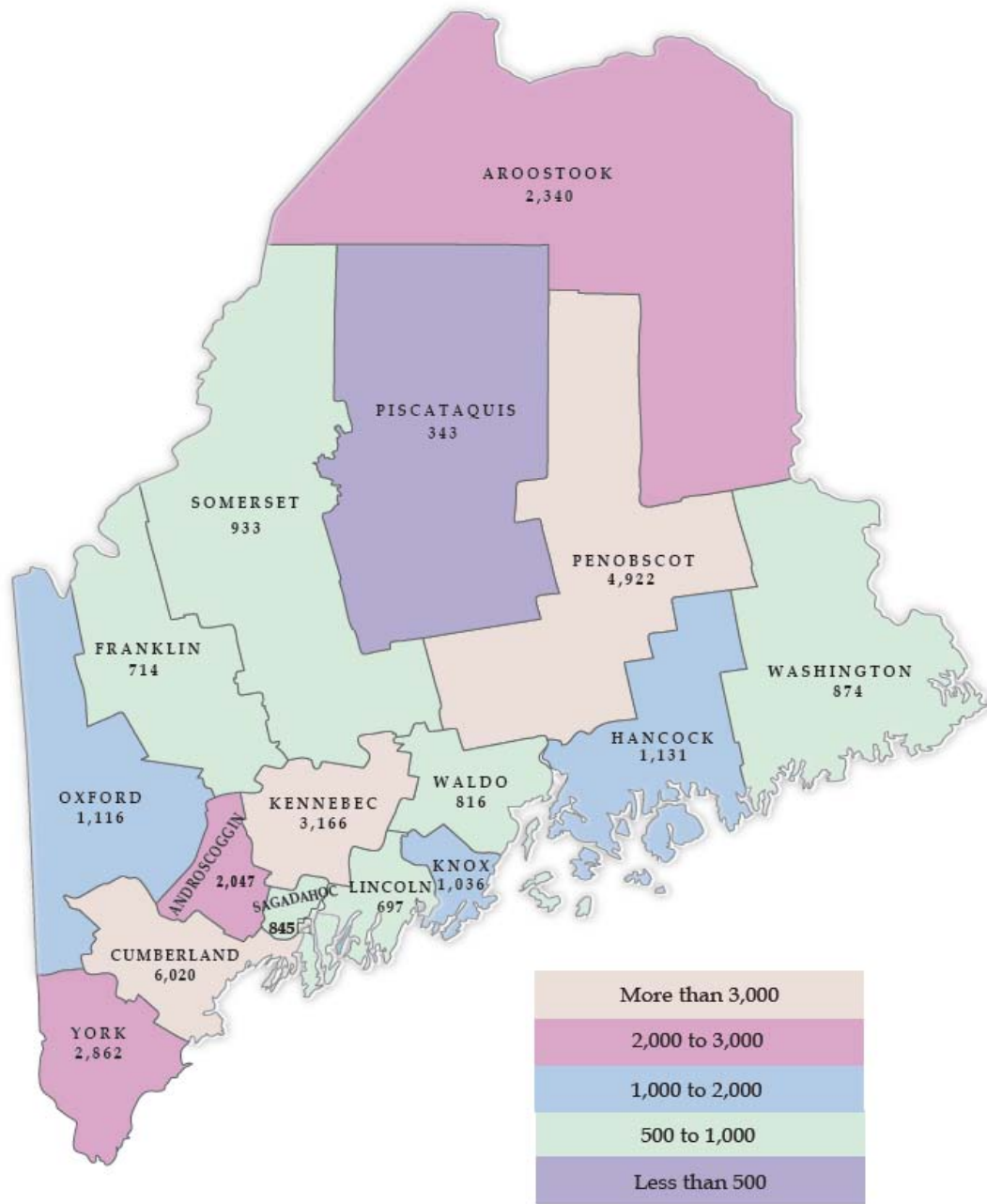
