### INTRODUCTION

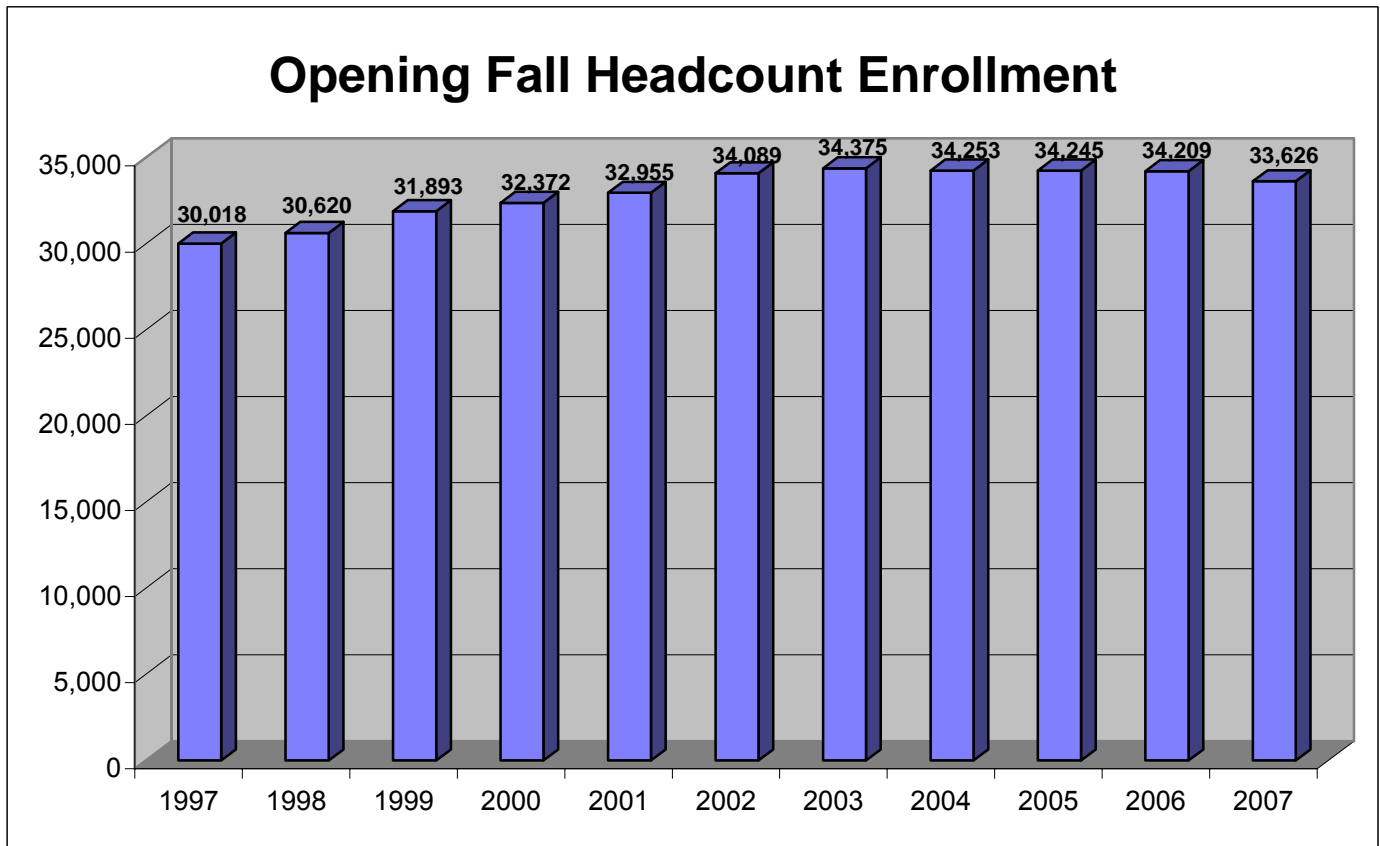
This report provides summary information regarding University enrollments. The tables and graphs show enrollments for the past 11 years, i.e., 1997-2007.

## **HIGHLIGHTS**

- **Full-time equivalent enrollment (FTE) remains at record-high levels above 24,000 FTE. At 24,056, this fall's FTE enrollment is slightly down by 0.8% from the Fall 2005 record high of 24,247.**
- **Fall 2007 headcount for Maine's public universities remains high, with 33,626 full-time and part-time students enrolled. The total reflects a modest 1.7 % decline in total enrollment as compared to last year's near-record high. UMS enrolls approximately 72% of students currently enrolled in public postsecondary education and 56% of students in public and private postsecondary education combined.**
- **First-time, first-year students are up by 1.6% (69 students) from 4,282 in Fall 2006 to 4,351 in Fall 2007. This is the second highest entering class since 1990.**
- **Over the past three years, the University of Maine System has experienced record-high enrollments in its four-year (bachelor's) degree programs. With 22,236 baccalaureate students, this fall is only slightly off last years all-time high of 22,375 students.**
- **UMS also continues to attract students across the United States and internationally. Non-resident enrollment of 4,268 students is the second highest in UMS history, off 98 students from last year's record of 4,347. Non-resident students represent all but one state and 79 countries.**



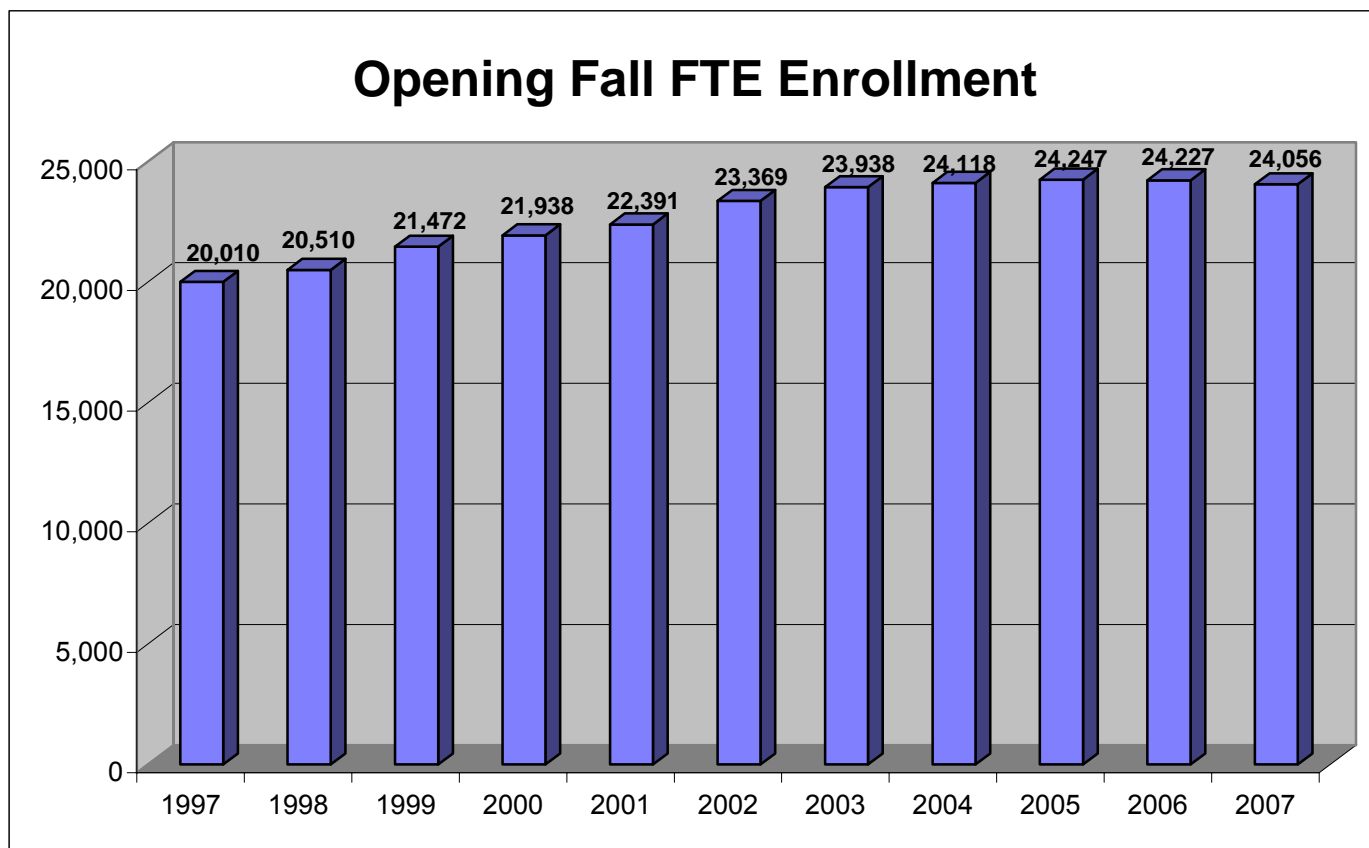

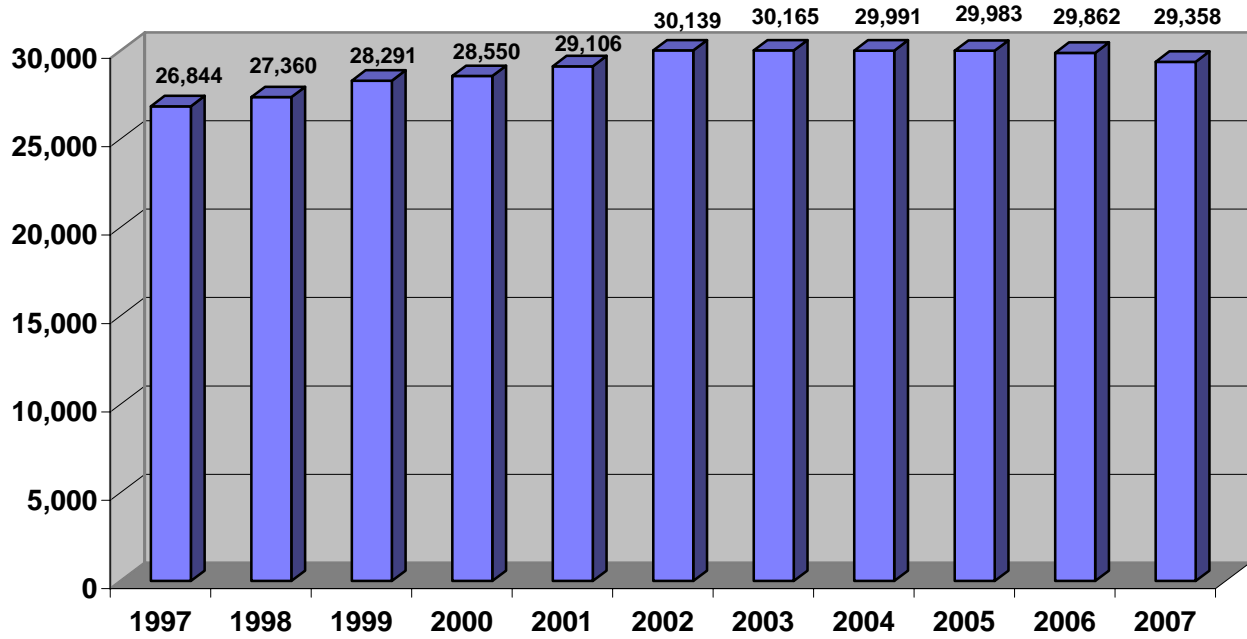

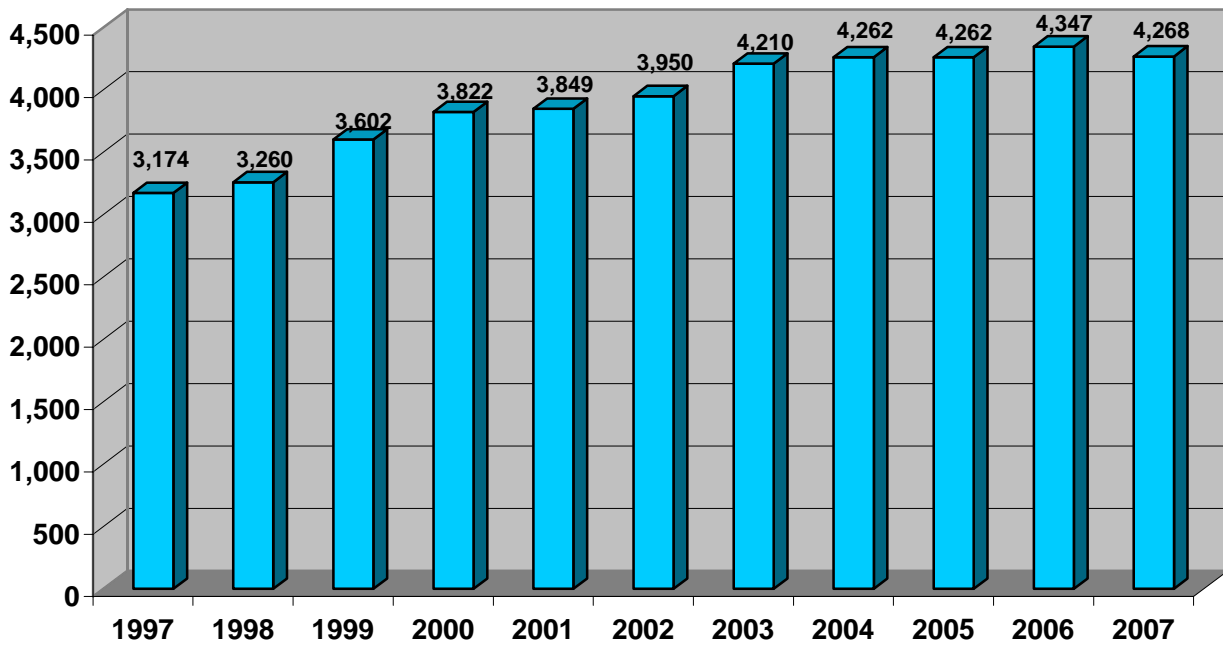

Opening Fall Out-of-State Enrollment

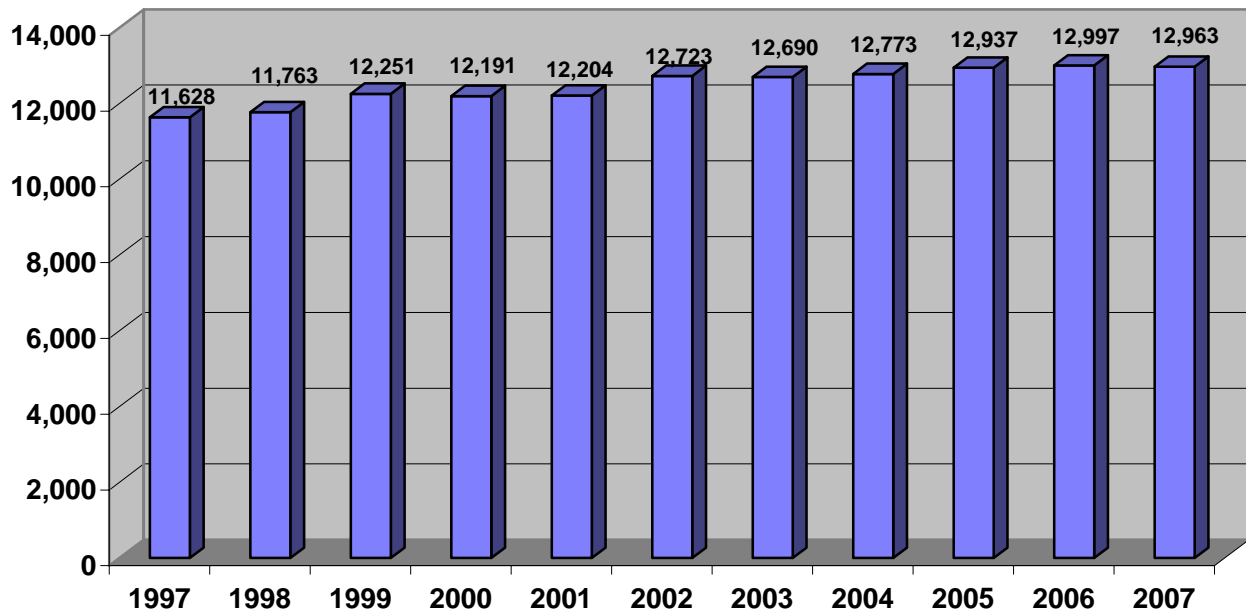

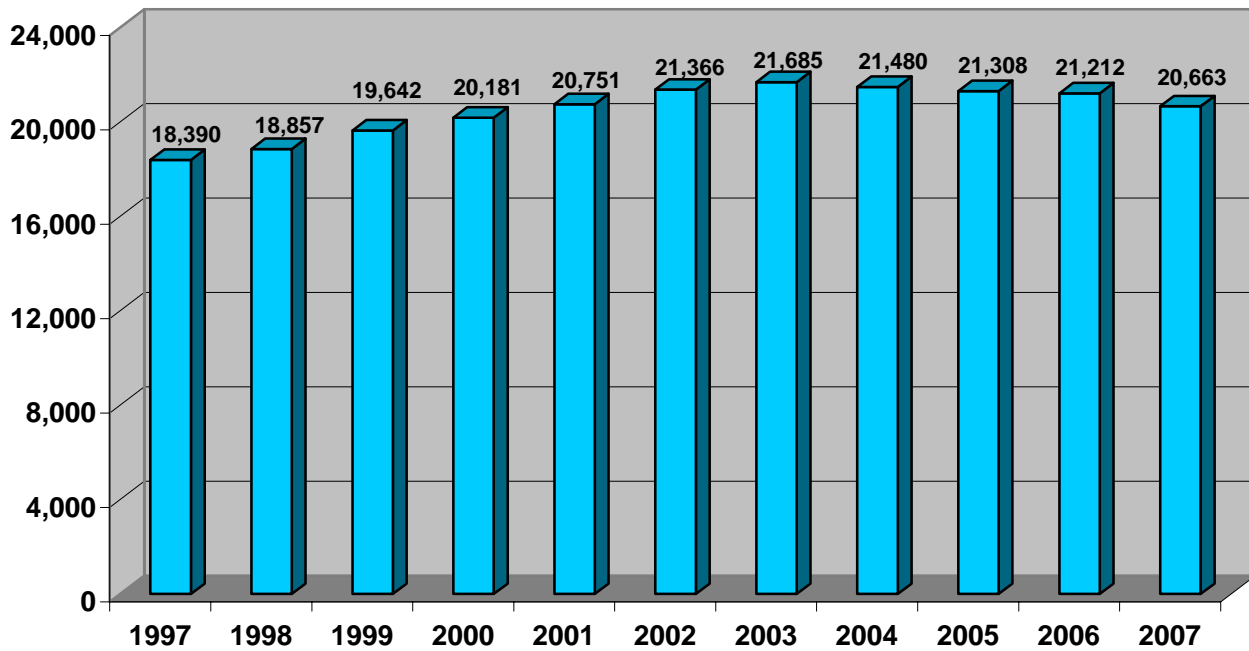

Opening Fall Enrollment - Women

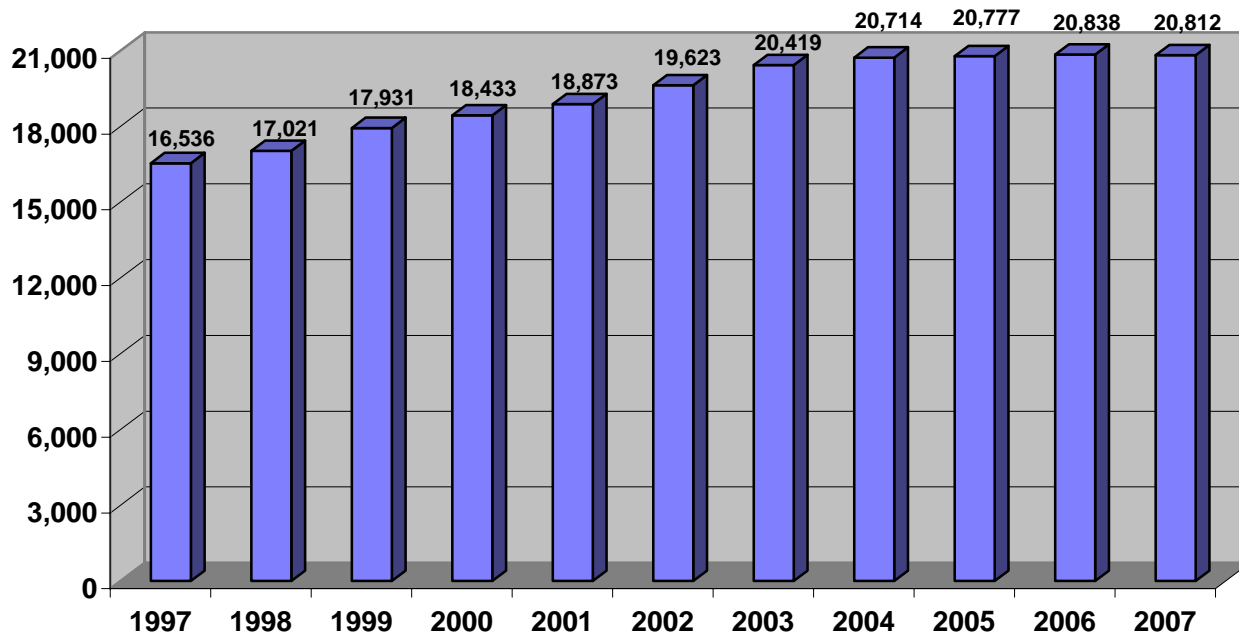

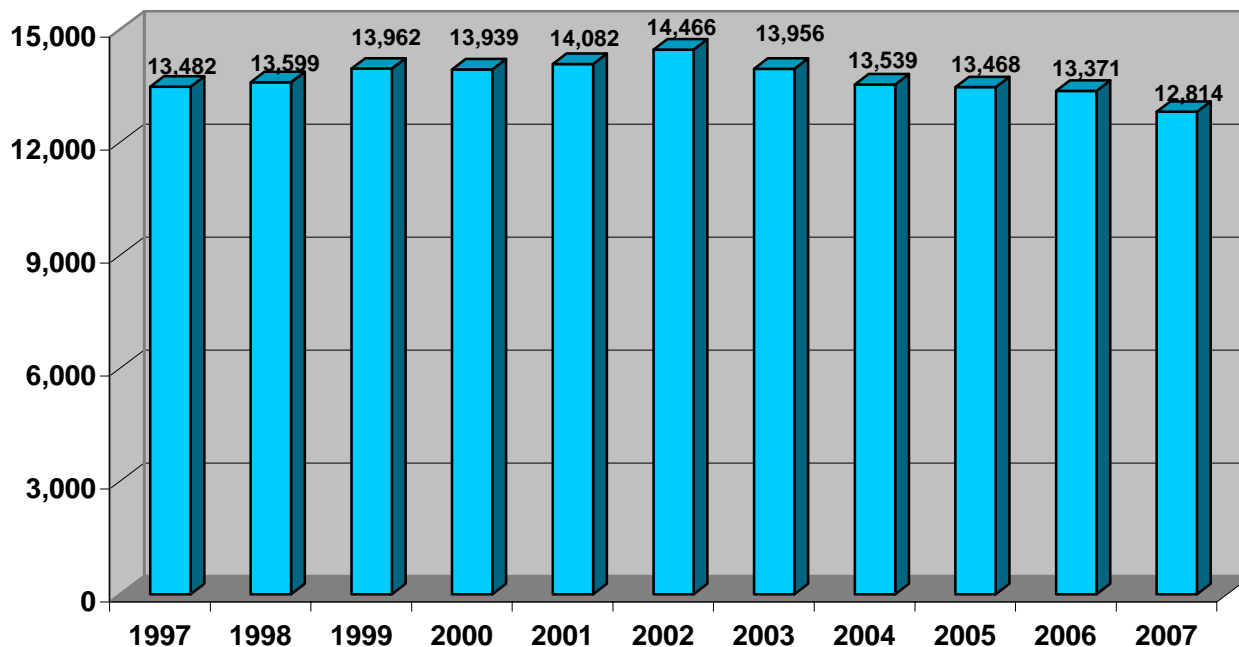

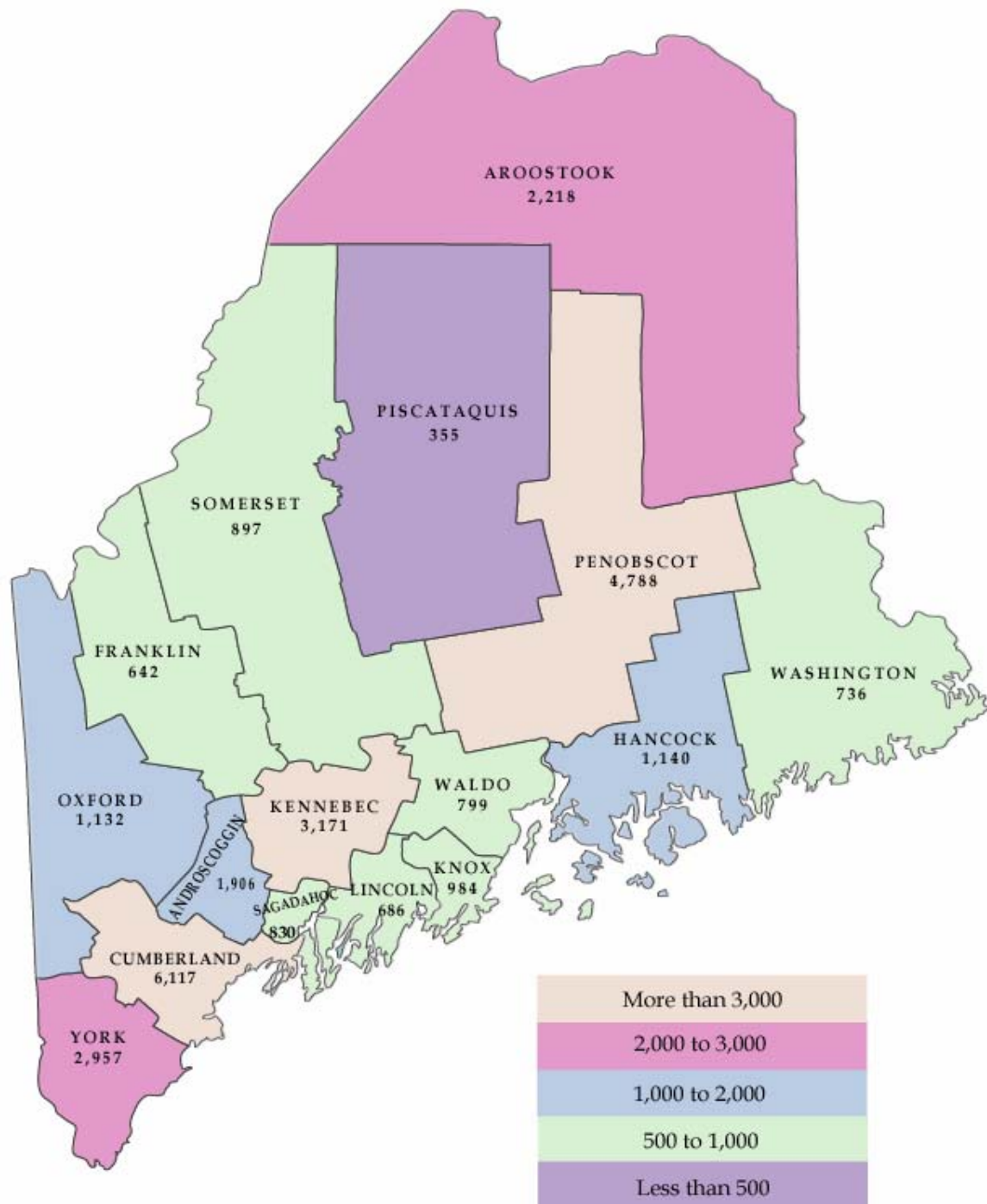
